ARTICLE 1 INTRODUCTION

1.1 Vizsla Silver Corp. and its subsidiaries (collectively the "**Company**" or "**We**") are committed to conducting our mining operations responsibly, ethically, and sustainably. We recognize the importance of our suppliers in achieving these goals.

1.2 The purpose of this Supplier Code of Conduct (the "**Code**") is to outline the Company's standards and expectations for its suppliers to ensure they align with the Company's values and principles. By doing business with the Company, suppliers agree to adhere to this Code and promote responsible practices throughout their supply chain.

1.3 **"Suppliers**" refer to any business partner, such as contractors, sub-contractors, individuals, joint venture partners, or other legal entity that provides goods and/or services to the Company under terms specified in a contract.

ARTICLE 2 RESPONSIBILITY

2.1 Procurement and department management, which the Supplier is contracted to support, are responsible for overseeing and enforcing this Code. It is their responsibility to identify and assess risk in the supply chain.

ARTICLE 3 EXPECTATIONS OF SUPPLIERS

3.1 Suppliers will comply with all applicable laws and regulations, including those related to mining, environmental protection, labor, health, safety, and human rights.

3.2 Suppliers will comply with all environmental laws and regulations and adhere to the Company's environmental policies and procedures. Suppliers will provide the Company with requested information pertaining to the supplier's greenhouse gas emissions and emissions related directly to the supplier's engagement with the Company's projects.

3.3 Suppliers will comply with the Company's standards and procedures related to health and safety.

3.4 Suppliers will comply with the Company's Community, Indigenous & Human Rights Policies.

3.5 Suppliers will not provide direct or indirect support to non-state armed groups through the extraction, transport, trade, handling, or export of minerals.



3.6 Suppliers will comply with the Company's Waste Management Policy. Throughout the exploration phase, management efforts are supported through orientation, weekly monitoring and meetings with the Environmental Superintendent.

3.7 Suppliers will comply with the Company's Anti-Bribery and Anti-Corruption Policy and the Whistleblower Policy.

3.8 The governance policies described within apply to all Suppliers.

3.9 This Code forms part of all agreements between the Company and its Suppliers. Suppliers are required to comply with this Code and to ensure that their employees and representatives understand and comply with this Code. Failure to adhere to this Code may be grounds for termination of the Supplier relationship and any related agreements.

ARTICLE 4 BREACHES OF THIS POLICY

4.1 Failure to comply with this Code may result in a review of the supplier relationship, including the potential termination of the contract. We believe in collaboration and aim to work with our suppliers to address any issues and improve responsible practices.

ARTICLE 5 EFFECTIVE DATE

5.1 This Code was implemented by the board of directors of the Company on December 15, 2023.
